Chairperson Benke opened the public hearing for the creation of Street Improvement Districts at 7:10 and asked for public input. The hearing was closed at 7:12. Benke introduced and read Resolution 03-25-14-01, to create street improvement districts. Motion by Benke, seconded by Rotert to approve. Upon roll call vote, voting YES: Lee, Benke, Rotert, Harrie, Hitchler. Voting NO: none, motion carried. A true, correct and complete copy is on file at the Village Office.

DISCUSSION/CONSIDERTION/ACTION

Mark Langan with the Nebraska Humane Society was present to discuss the possibility of the Village signing a contract to have the Humane Society enforce animal regulations. The board will revisit the contract at budget time.

Motion by Lee, seconded by Hitchler to approve West Shores Interlocal Agreement contingent on approval of amendment to the sewer interlocal agreement. Upon roll call vote, voting YES: Benke, Rotert, Harrie, Hitchler, Lee. Voting NO: none, motion carried.

Voting NO: none, motion carried. Motion by Lee, seconded by Benke to approve. Upon roll call vote, voting YES: Harrie, Hitchler, Lee, Benke, Rotert. Voting NO: none, motion carried. Lee introduced and read Ordinance 734-Curb Cutting Regulations. Motion by Benke, seconded by Lee to waive the three readings. Upon roll call vote, voting YES: Hitchler, Lee, Rotert, Benke, Harrie. Voting NO: none, motion carried. Motion by Lee, seconded by Benke to approve. Upon roll call vote, voting YES: Hitchler, Lee, Benke, Rotert, Harrie. Voting NO: none, motion carried. A true, correct and complete copy is on file at the Village Office.

Benke introduced and read Resolution 03-25-14-02, to set fees for street cutting. Motion by Rotert, seconded by Lee to approve. Upon roll call vote, voting YES: Benke, Rotert, Harrie, Hitchler, Lee. Voting NO: none, motion carried. A true, correct and complete copy is on file at the Village Office.

Johnson presented a letter submitted by R Bar & Grill stating that they did not want to have Keno in their establishment using the current lottery provider.

Benke introduced and read Resolution 03-25-14-03, to increase the salary for the Clerk's position. Motion by Hitchler, seconded by Rotert to approve. Upon roll call vote, voting YES: Benke, Rotert, Harrie, Hitchler, Lee. Voting NO: none, motion carried. A true, correct and complete copy is on file at the Village Office.
