Harlow introduced and read Ordinance 777, to approve employee wages. Motion by Hitchler, seconded by Lee, to waive the three readings. Upon roll call vote, voting YES: Hitchler, Rotert, Lee, Harlow. Voting NO: none, Pojar was absent. Motion carried. Motion by Rotert, seconded by Hitchler, to approve Ordinance 777 with the change of making Adam Smith's salary \$16/hr. Upon roll call vote, voting YES: Harlow, Lee, Rotert, Hitchler. Voting NO: none, Pojar was absent. Motion carried. A true, correct and complete copy is on file at the Village Office.

The Board reviewed the flyer for Clean-up Day and it was approved including it in the utility bills.

Harlow introduced and read Resolution 03-28-17-06, to approve use of up to \$100 in keno funds for the Park and Tree Board Arbor Day Celebration. Motion by Hitchler, seconded by Rotert to approve. Upon roll call vote, voting YES: Rotert, Lee, Harlow, Hitchler. Voting NO: none, Pojar was absent. Motion carried. A true, correct and complete copy is on file at the Village Office.
