

ORDINANCE NO. 766

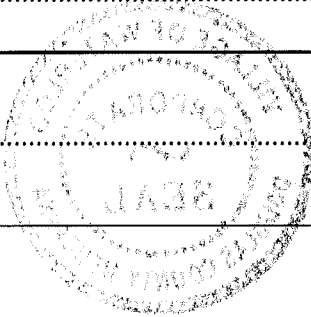
AN ORDINANCE RESCINDING AND REPLACING ORDINANCE 763 TO CHANGE THE WASTEWATER RATES FOR THE USE OF THE WASTEWATER SYSTEM OF WATERLOO, NEBRASKA, ON A JUST AND EQUITABLE BASIS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECT DATE OF THIS AMENDMENT.

BE IT ORDAINED BY THE CHAIRPERSON AND BOARD OF TRUSTEES OF THE VILLAGE OF WATERLOO, DOUGLAS COUNTY, NEBRASKA, THAT ORDINANCE NO. 707 OF THE VILLAGE OF WATERLOO IS HEREBY AMENDED TO PROVIDE AS FOLLOWS:

1. Section III of Ordinance No. 707 is hereby repealed in its entirety and the following Section III is hereby adopted:

“SECTION III. For the purpose of paying the capital and operating costs of the Wastewater System, the following wastewater rates to be charged against each lot, parcel of land or premises served by said System are hereby established effective _____, 2016:

VOLUME RATE

For each 1,000 gallons of water, or portion thereof, in excess of 3,000 gallons, delivered by the Village each month through the Consumer's meter:

All Consumers:

Wastewater Charge

\$ 4.30

Residential: Based on the average water volume from October through April of the prior year.

Commercial: Based on the current month's water volume.

2. Ordinance No. 707 shall remain in full force and effect as hereby amended.
3. If any section, clause, provision, or part or portion of any section, clause, or provision of this Ordinance or the application thereof to any person or circumstance is held unconstitutional, such invalidity or unconstitutionality shall not affect the validity or application of any other section, clause, provision or part or portion of this Ordinance.
4. This Ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.
