ORDINANCE NO. 132

AN ORDINANCE CREATING STREET IMPROVEMENT DISTRICTS NOS. 2014-1, TO 2014-6 INCLUSIVE IN THE VILLAGE OF WATERLOO, NEBRASKA, ORDERING THE CONSTRUCTION OF STREET IMPROVEMENTS THEREIN AND ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM.

BE IT ORDAINED BY THE CHAIRPERSON AND BOARD OF THE VILLAGE OF WATERLOO, NEBRASKA, as follows:

- Section 1. That there be and hereby are created in the Village of Waterloo, Nebraska, Street Improvement Districts to be known and designated as Street Improvement District Nos. 2014-1 to 2014-6 inclusive of the Village of Waterloo, Nebraska.
- Section 2. That the outer boundaries of Street Improvement District No. 2014-1 shall include, in addition to the streets to be improved, all of the property abutting upon said streets to be improved and within which District, the following streets shall be improved by asphalt overlay, with intersection replacement and drainage improvements and all necessary appurtenances thereto:

Robinson Blvd., from Highway 64 to Lincoln Ave., and

Lincoln Ave., from 1st Street to 7th Street,

which are found to be intersecting streets.

Section 3. That the outer boundaries of Street Improvement District No. 2014-2 shall include, in addition to the street to be improved, all of the property abutting upon said street to be improved and within which District, the following street shall be improved by asphalt overlay and all necessary appurtenances thereto:

Washington Ave., from 1st Street to 7th Street.

Section 4. That the outer boundaries of Street Improvement District No. 2014-3 shall include, in addition to the street to be improved, all of the property abutting upon said street to be improved and within which District, the following street shall be improved by asphalt overlay and all necessary appurtenances thereto:

North Front Street, from 1st Street to Dryers Road.

Section 5. That the outer boundaries of Street Improvement District No. 2014-4 shall include, in addition to the street to be improved, all of the property abutting upon said street to be improved and within which District, the following street shall be improved by asphalt overlay and all necessary appurtenances thereto:

South Front Street, from 1^{st} Street to 7^{th} Street.

Section 6. That the outer boundaries of Street Improvement District No. 2014-5 shall include, in addition to the street to be improved, all of the property abutting upon said street to be improved and within which District, the following street shall be improved by asphalt overlay and all necessary appurtenances thereto:

Jefferson Street, from 1st Street to 7th Street.

Section 7. That the outer boundaries of Street Improvement District No. 2014-6 shall include, in addition to the streets to be improved, all of the property abutting upon said streets to be improved and within which District, the following streets shall be improved by asphalt paving, with gutter replacements at certain intersections and all necessary appurtenances thereto:

Madison Street, from 1st Street to 7th Street, Cedar Drive, from Madison Street to 204th Street, Walnut Circle, from Cedar Drive to its terminus, Elm Circle, from Cedar Drive to its terminus, Oak Street, from Cedar Drive to 2nd Street, and Cedar Hollow Mall, which intersects Cedar Drive at each end;

which streets are found to be interconnecting streets.

Section 8. Said streets shall be improved at public cost and said improvements shall be made in accordance with the plans, specifications and estimate prepared by the special engineers for the Village and to be approved by the Chairperson and Board.

Section 9. Notice of the creation of said Districts shall be published as provided by law in the DUMNING COUNTY PUST CHAPTED a legal newspaper published in Douglas County and of general circulation in Waterloo, Nebraska.

Section 10. This ordinance shall be published in pamphlet form and take effect as provided by law.
