ORDINANCE NO. 837

AN ORDINANCE TO CHANGE THE MONTHLY METER CHARGES AND MONTHLY WATER RATES FOR THE USE OF THE WATER DISTRIBUTION SYSTEM AND THE PURCHASE OF WATER FROM THE VILLAGE OF WATERLOO, NEBRASKA, ON A JUST AND EQUITABLE BASIS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH; AND PROVIDING FOR AN EFFECT DATE OF THIS AMENDMENT.

BE IT ORDAINED BY THE CHAIRPERSON AND BOARD OF TRUSTEES OF THE VILLAGE OF WATERLOO, DOUGLAS COUNTY, NEBRASKA, THAT ORDINANCE NO. 765 OF THE VILLAGE OF WATERLOO IS HEREBY AMENDED TO PROVIDE AS FOLLOWS:

1. Section III of Ordinance No. 826 is hereby repealed in its entirety and the following Section III is hereby adopted:

"SECTION III. For the purpose of paying the capital and operating costs of the Water System, the following monthly meter charges and water rates to be charged against each lot, parcel of land or premises served by said Water System are hereby established effective upon the effective date of this ordnance:
