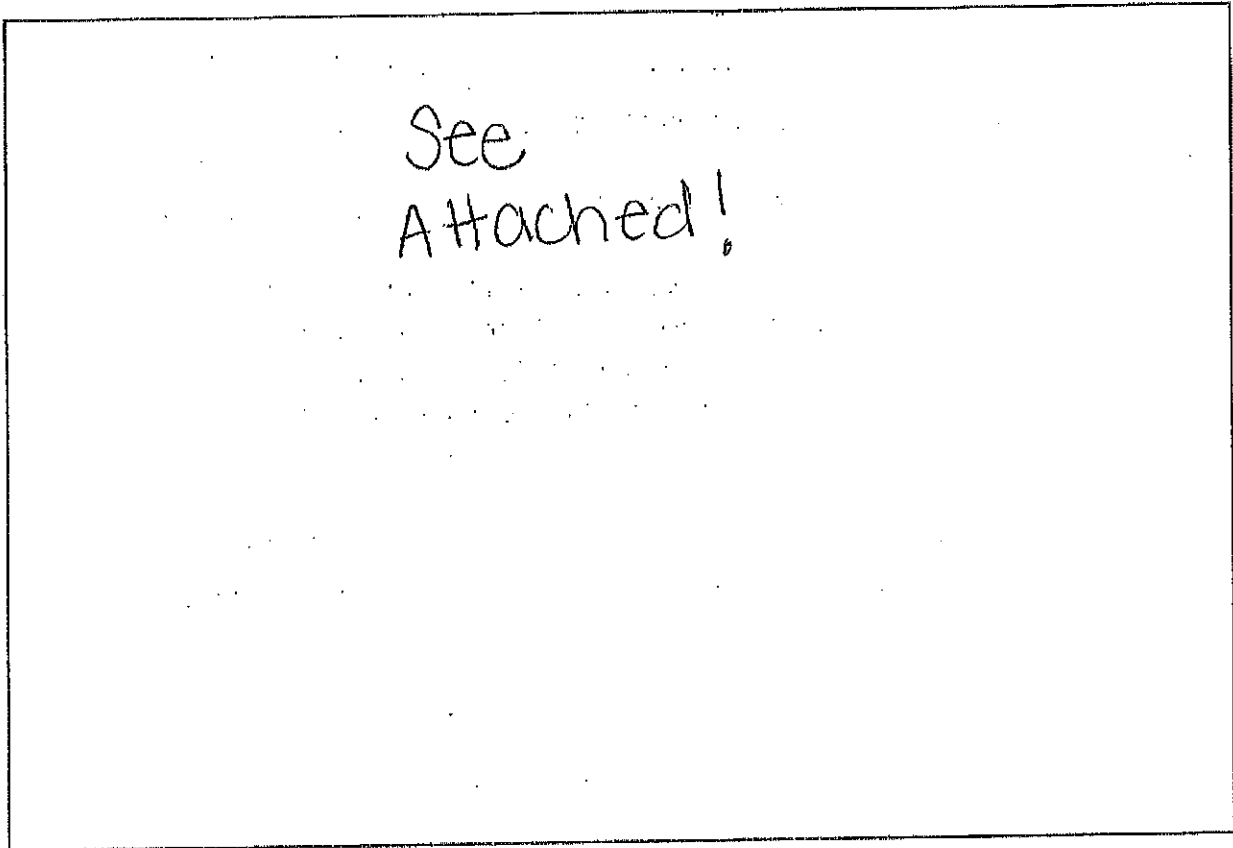

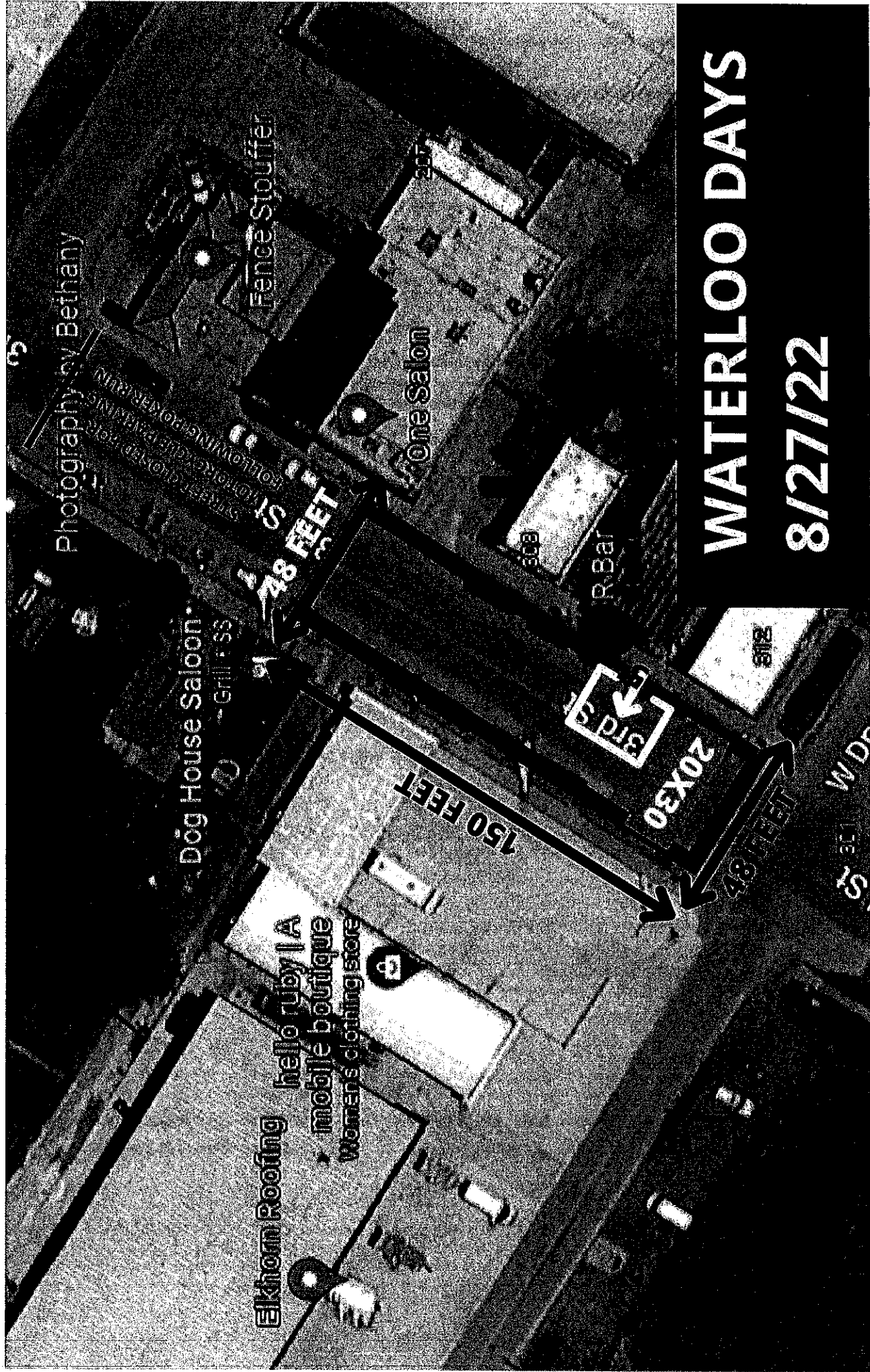
OUTDOOR AREA DIAGRAM

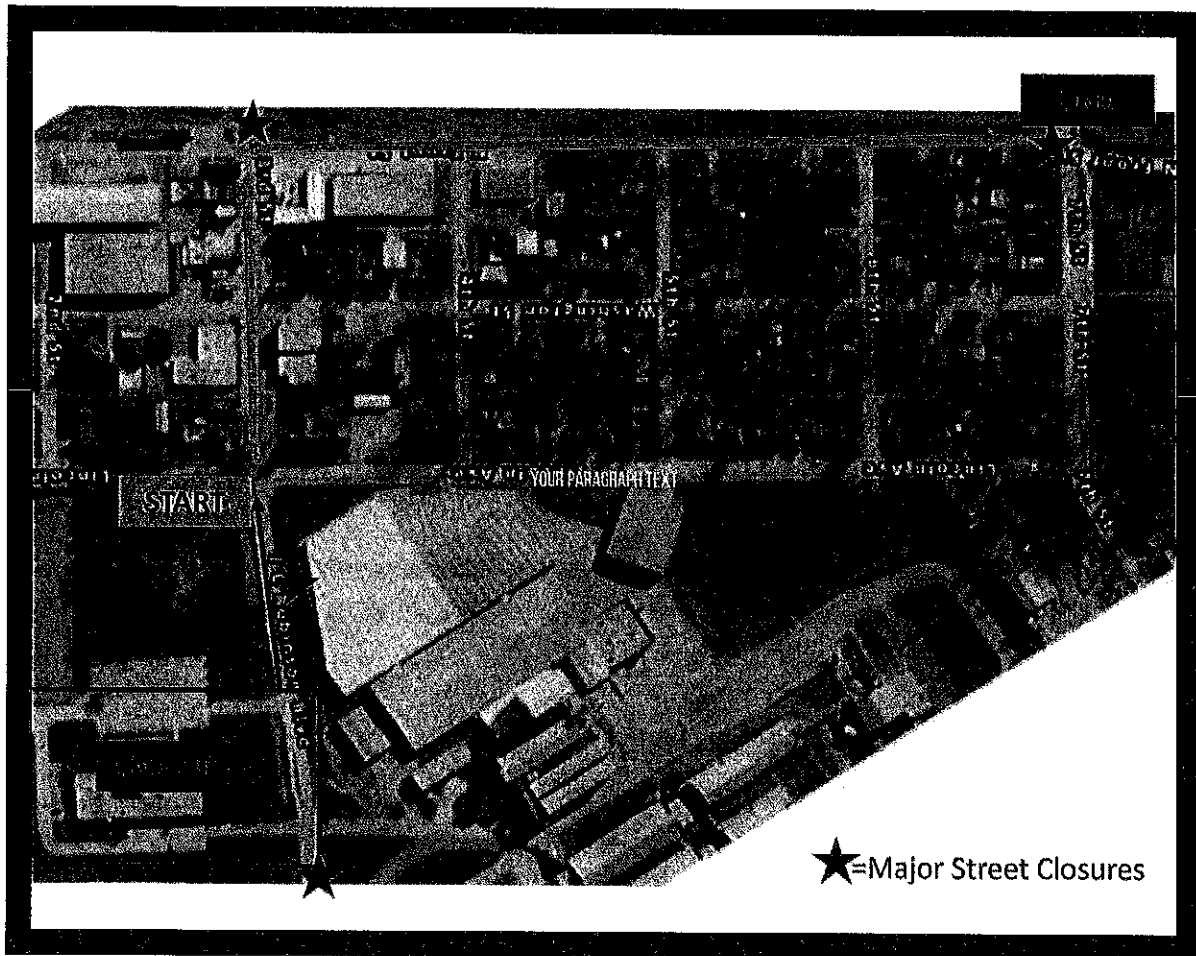

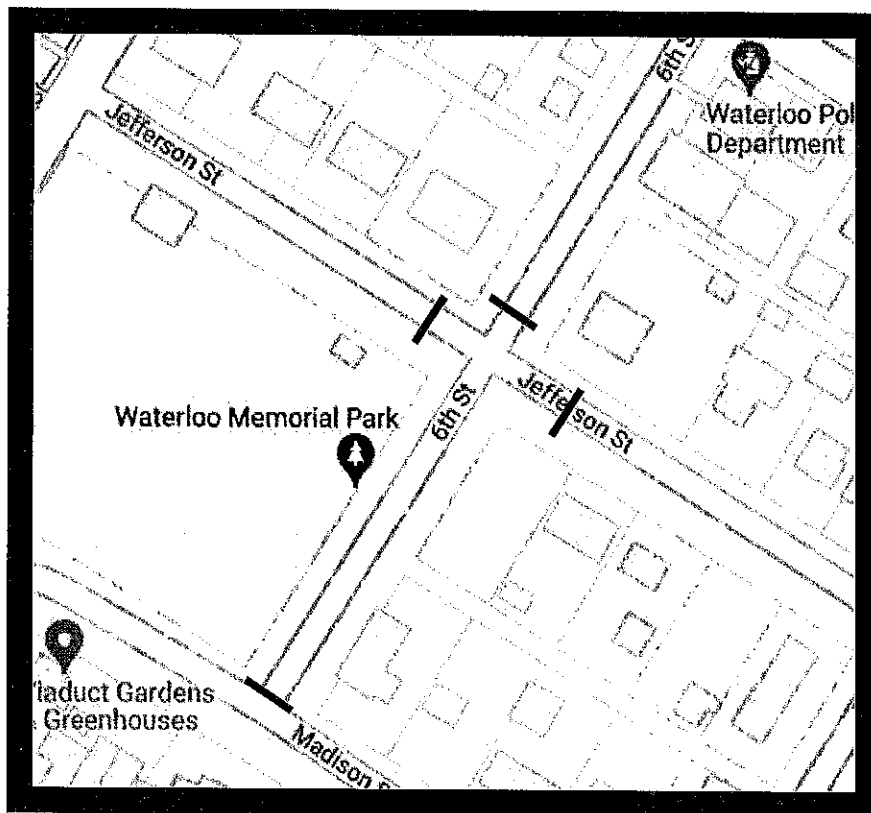
