WHEREAS, the Board of Trustees is in agreement with Harlow that the Fire Department has a need for the items listed in the attached quotes



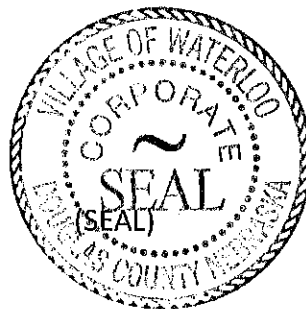
THAT, the attached quote is hereby approved in the amount of \$30,350.80 for the Fire Department.


