**WHEREAS**, the Board of Trustees is in agreement with Bednar that the Maintenance Department has a need for the repairs.

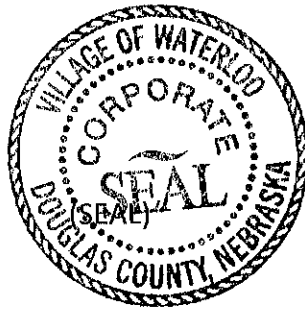

**Article 4**  
Contract Fee and Billing

The Client shall compensate TREKK Design Group for Scope of Services described above and in accordance with Terms and Conditions of this Agreement.

1. For **FIELD SERVICES** compensation shall be based on a unit rate basis as shown in the different sections below.
  - i. Section A: 5th & Washington to 5th & N. Front, heads east to the east of Nutrient 2332. Pipe size 12", 12 pipes. 3rd & Lincoln to ditch, 60' of 10", 1 pipe / segment. **Total Section A Clean 2,392 LF @ \$1.50/LF = \$3,588.00**
  - ii. Section B: 5th Jefferson through Levee at 7th street, 1630' of 12", 5 pipes. 7th & S. Front along 7th street, 404' of 10", 2 pipes. By fire station, 20', 3 pipes. **Total Section B Clean 2,054 LF @ \$1.50/LF = \$3,081.00**
  - iii. Section C: 3rd & Madison to 2nd & Madison, South to ditch, 1805' of 12", 2 pipes. 2nd & Madison to 2nd & Denton, 16", 6 pipes. River Road Ave. North to ditch, 65' of 12", 1 pipe. Cedar Mall Drive East side, West side, South side, 95' of 18", 3 pipes. **Total Section C Clean 1,965 LF @ \$1.50/LF = \$2,947.50**
  - iv. Section D: Denton to pond, 203' of 24", 1 pipe. Denton to middle, 170' of 24", 1 pipe. Kelsey to middle, 150' of 24", 1 pipe. Kelsey to middle, 130' of 24", 1 pipe. Agee Lane east to Blondo water area, 155' of 24", 1 pipe. Agee Lane west to Blondo water area, 160' of 24", 1 pipe. Agee Lane west to middle, 160' of 24", 1 pipe. Agee Lane east to pond, 176' of 24", 1 pipe. Thomas Dr. to ditch, 187' of 24", 1 pipe. **Total Section D Clean 1,491 LF @ \$1.50/LF = \$2,236.50**
  - v. Section E: Harvest Heights 23832 to pond, 591' of 14", 3 pipes. 407 Madison (storm sewer is actually on Harvest Heights Cir.), 206' of 14", 1 pipe. **Total Section E Clean 797 LF @ \$1.50/LF = \$1,195.50**
2. **Grand total of all sections = \$13,048.50**

All work shall be performed according to our **Standard Terms and Conditions of Contract**, incorporated into this contract by reference herein and attached as Exhibit A.
