RESOLUTION NO. 9-10-13-02**

WHEREAS, the Board of Trustees of the Village of Waterloo renewed the Operation and Maintenance Agreement with the PeopleService on September 13, 2011; and,

WHEREAS, the Agreement allows for an annual adjustment of the maximum annual maintenance/repair (non-capital) expenditure amount and the monthly compensation the Village of Waterloo pays for services; and,

WHEREAS, the annual adjustment is to be based on the change in the Consumer Price Index for All Urban Consumers (CPI-U) dated between July of the previous year to July of the current year; and,

WHEREAS, the change in CPI-U for July 2012 to July 2013 was a positive 2.0%; and,


WHEREAS, the Village of Waterloo's maximum annual maintenance/repair (non-capital) expenditure amount will be increased from \$9,493 to \$9,683 and the monthly compensation will be increased from \$10,752 to \$10,967.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF WATERLOO, NEBRASKA, AS FOLLOWS:

THAT, the Operation and Maintenance Agreement has been adjusted to reflect the increase in the Consumer Price Index resulting in a maximum annual maintenance/repair (non-capital) expenditure amount of \$9,683 and the monthly compensation of \$10,967.



Dear Chairman Benke,

Pursuant Paragraphs 1.3 and 4.2 of the Operations and Maintenance Agreement dated September 14, 2011 between the Village of Waterloo, Nebraska and PeopleService, Inc., the maximum annual maintenance/repair (non-capital) expenditure amount and the monthly compensation the Village of Waterloo, Nebraska pays for our services are to be adjusted each October 1st. This adjustment is to be based on the change in the Consumer Price Index for All Urban Consumers (CPI-U) between July of 2012 and July of 2013.

The change to the CPI-U was a positive 2.0%. Thus, effective October 1, 2013, the Village of Waterloo's maximum annual maintenance/repair (non-capital) expenditure amount will be increased from \$9,493 to \$9,683 and the monthly compensation will be increased from \$10,752 to \$10,967.
